If the breed of animal I’m adopting must be given daily walks or exercise outside of their dwellings, a collar and/or harness shall be placed on the pet at all times, while the animal is off of the adopter’s property.

2. I will not part with the possession of _____, except to return them to the Owner. If I do give up _____ for any reason and do not tell the Owner prior, I will be liable for all costs, including legal costs, that incur from recovering_____.
3. I will give _____ a chance to adjust to their new home. If _____ not a good fit, I will return said pet to Shangri-La Sanctuary as soon as possible. It is up to the sole discretion of Shangri-La Sanctuary if another pet will be considered instead, or if a refund will be made to adopter.
4. I will feed and house _____ to the Owners satisfaction. If it is found that they have not done so, the Owner can claim back possession of _____.
5. I will never chain _____, unless it is 100% necessary, and discussed with Shangri-La Sanctuary first. If _____ is found to be chained, either inside or outside the home, they can and most likely will be removed from my care.
6. I can afford the services of a veterinary practitioner in my state.
7. I agree to keep _____ vaccinations up to date. If an injury occurs, I will take _____ to a veterinarian to seek treatment. I will not deny treatment unless the treatment has a low success rate or would prolong the life of a terminally ill, suffering pet, or they have reached the age where significant improvement is unlikely. If I cannot afford treatment, I will contact Shangri-La Sanctuary for possible help.
8. I understand that in the event of an illness (not injury) occurring within the first seven (7) days of adoption, I will contact Shangri-La Sanctuary immediately.
9. I understand, know, and acknowledge the "By-Laws Pertaining to Dogs" of the municipality in which I reside. Should I move, I agree to research said state's by-laws.
10. I will permit the Owner or an authorized officer dispatched by the Owner to visit my dwellings, to be assured that _____ is being treated in accordance with this Agreement, and I will allow Shangri-La Sanctuary to recover ownership of _____, if, in the Owner's opinion, the terms of this Agreement are not being reasonably adhered to.
